Key Responsibilities

- Uphold TRC's mission to provide peer-guided, unbiased, and evidence-based educational solutions.
- Develop editorial content for subscribing pharmacists, pharmacy technicians, prescribers, nurses, and other health care professionals. Areas of focus will include, but not be limited to, medication therapy, current practice standards, and regulatory practice requirements.

- Collaborate, as needed, with marketing, sales, product management, customer service and other groups within TRC to meet client needs.
- Other responsibilities as may be assigned to support the Editorial Group or TRC.

- PharmD or BS in Pharmacy with a minimum of 3 years' experience in pharmacy practice. Five or more years of experience preferred. PharmD preferred.
- Pharmacy residency preferred.
- Board certification (e.g., Board Certified Pharmacotherapy Specialist) preferred.
